ProTEQ GUN SAFETY RULES

Page 1 of 2

1. Assume all Guns are **Loaded**, = Treat **ALL** guns as if they are **always** loaded **all the time**.
2. Point the Gun in a Safe **Direction**, = ALWAYS Think about the direction the gun is pointed. Point it **down** at the ground or at the **target**.
3. Never Put Your Finger on the **Trigger**, till the Sights are on the Target, = Keep your **finger off the trigger** and out of the trigger guard.  
Keep your finger pressed upon the side of the gun frame, or slide, until the barrel is pointed at the target.
4. Be Sure of the **Target**, = Identify the target and what is beyond it. Be sure of what you are shooting. **KNOW** where your bullet **STOPS**.

## ProTEQ RANGE REGULATIONS

1. COMPLETE the daily **SIGN IN / SIGN OUT** sheet in each Valley (West or South) **every time** you are present.
2. Pick up **ALL your shell casings** & put them in the buckets marked **BRASS, STEEL, or ALUMINUM**. Use a **TARP**, the easy way to clean up.  
If you reload take **YOUR** casings, but **DO NOT** take any others or any out of the buckets - That is considered stealing from the Range.
3. Pick up your **SHOTGUN** hulls, put them in the buckets marked **SHOTGUN**.
4. Throw **ONLY Burnable Trash** in the TRASH BARRELS. **Take** all your **NON-burnable** trash **with you**. I'm not your **DUMP!!!**
5. Pick Up, Straighten Up, Take Down, Fold Up, and Put Away everything you use every time you use it.
6. **Clean off the Target boards** before you leave. Take down **EVERY target** you put up or find up. **Do NOT** put **ADHESIVE** targets **directly on the plastic**. Put those Adhesive targets on paper and **STAPLE** them to the plastic target boards.
7. Do **NOT** put targets on, over, near, on top of, or in front of the **posts** holding up the backboards. Absolutely **No High Targets** are allowed on the...  
...Top of the backboards, posts, tires, logs, or any other point close to the top of or on top of the dirt (or other) impact berms.
8. Shoot so that all bullets impact the plastic target boards or the **dirt backstop impact berms**.
9. Don't shoot **TRASH** such as glass, concrete blocks, tin cans, bricks, textbooks, rocks, computers, fire extinguishers, mufflers, etc., including  
Any other Non-Burnable trash brought to or found on the range. Don't shoot center fire rifle ammo into steel targets at **less than 40 yards**.
10. Keep **all Loaded Handguns holstered** when behind the firing line AND keep all other guns **open chambered - open and empty**...  
Until that gun is on the firing line. **No loaded guns are allowed to be un-holstered or uncased behind the firing line**.
11. You are responsible for yourself and any child, minor, dependent, or **FIRST TIME MEMBER** you bring to the range.
12. There are **NO Free Visits, NO First Times Discounts, NO Guest Specials, ALL Persons** (18 or older) **MUST** fill out a Range Release and Pay at least the Standard Membership **FEE**. **NO EXCEPTIONS!!!** The Guest Program was abused and is now **TERMINATED** because of that abuse. Tell the Friend you plan to bring to the Range that they have to **JOIN** as a Member or **Stay OFF** the property..... SEE the **FAQ** page on the website.
13. Report any rule breaking or infractions you witnessed or know about to the Directors, Staff, and/or Owner.
