ProTEQ GUN SAFETY RULES

Page 1 of 2

1. Assume all Guns are **Loaded**, = Treat ALL guns as if they are **always loaded all the time**.
2. Point the Gun in a Safe **Direction**, = ALWAYS Think about the direction the gun is pointed. Point it **down** at the ground or at the **target**.
3. Finger off the **Trigger**, till the Sights are on the Target, = Keep Your **Finger OUT of the trigger guard** until the barrel points at the target.
4. Be Sure of the **Target**, = Identify the target and what is beyond it. Be sure of what you are shooting. **KNOW** where your bullet **STOPS**.

ProTEQ RANGE REGULATIONS

1. FILL OUT, SIGN, DATE, & PAY the Current Calendar Year Range Release (RR) BEFORE entering any Range Area.
2. COMPLETE the daily **SIGN IN / SIGN OUT** sheet in each Valley (West, South, or Long Ranges) **every time** you are present.
3. Pick up **ALL your shell casings** & put them in the buckets marked **BRASS, STEEL, or ALUMINUM**. Use a TARP, the easy way to clean up.
If you reload take YOUR casings, but DO NOT take others brass or any out of the buckets - That is considered stealing from the Range.
4. Pick up your SHOTGUN hulls, put them in the buckets marked SHOTGUN.
5. Throw ONLY **Burnable Trash** in the TRASH BARRELS. **Take all your NON-burnable trash with you**. I'm not your DUMP!!!
6. Pick Up, Straighten Up, Take Down, Fold Up, and Put Away everything you use every time you use it.
7. **Clean off the Target boards** before you leave. Take down EVERY **target**. **Do NOT** put ADHESIVE targets **directly on the plastic boards**.
Put those Adhesive targets on paper and STAPLE them to the plastic target boards.
8. Do NOT put targets on, over, near, on top of, or in front of the **posts** holding up the backboards. Absolutely **No High Targets** are allowed on the...
...Top of the backboards, posts, tires, logs, backstops, or any other point close to the top of or on top of the dirt (or other material) impact berms.
9. Shoot so that all bullets impact the plastic target boards, steel targets, and/or the **backstop impact berms**. Bullet must ALWAYS stop in the berm!!!
10. Don't shoot **TRASH** such as glass, concrete blocks, tin cans, bricks, textbooks, rocks, computers, fire extinguishers, mufflers, etc., including
Any other Non-Burnable trash brought to or found on the range. Don't shoot center fire rifle ammo into steel targets at **less than 40 yards**.
11. Keep **all Loaded Handguns holstered** when behind the firing line AND keep all other guns **chamber open and empty**...
Until that gun is on the firing line. **No loaded guns are allowed to be un-holstered or uncased behind the Firing Line**.
12. You are responsible for yourself and/or any child, minor, dependent, or other person (Single Day Patron) you bring to the range.
13. Report any rule breaking or infractions you witnessed or know about to the Directors, Staff, and/or Owner.

I/WE, the **Assignee(s)**, agree that the **Property** Directors, Staff, and/or Owner shall assume NO responsibility for the **Assignee(s)** own personal property, or damage to any other **Assignee's** property, AND THAT I/WE, the **Assignee's** are fully responsible for my/our own actions, conducts, accidents, injuries, wrongful methods, damages, destructions, or death, while on or having been on the **Property**.

I/WE, the **Assignee's**, agree and understand that any failure to comply with the **Property** Rules, Regulations, or Directives shall result in the termination of MY/OUR current and future privileges to use the **Property**.

4 Major Categories of FULL YEAR (365 Day) ProTEQ Range Membership

ALL Memberships Expire - 365 Days After the signature date of the completed Range Release (effective 11/01/19 – ALL PRIOR RR's are VOID).

ALL Adults - 18 or older & present on the property **MUST** have a current & paid Range release.

Some categories have specific discounts for certain occupations or variations in offerings – **SEE PAGE 2 for Details and to complete the Range Release form**.

There are **NO** Guests --- **NO** Visitors --- **NO** Observers --- **NO** FREEBIES --- YOU are on a **Range Release** or You're **OFF the Property** --- **NO Exceptions!!!**

Standard - (This ONLY includes the West Valley, the original range for shotgun, pistol, and rifle out to 200 yards. **YOU DO NOT have permission to any other areas of the property.**)

SCSA - (This is for ProTEQ Steel Challenge (**StCh**) Competitors and ONLY includes the Steel Challenge (SCSA) Valley. **YOU DO NOT have permission to any other areas of the property.**)

Premium - (This includes BOTH the West & South Valleys. The South Valley contains the shooting areas - Covered Pistol, Wide Rifle, Transition, 22/4U, MPR, & C.A.R.)*

Platinum - (This includes All Three Valleys - South, West, & Long Range Valley (LRV) - currently 400 yards / under construction to 600 yards -)*

*Premium or Platinum Members can **chaperon** a Single Day Patron onto the Valleys included in their Premium or Platinum package, but **NO Single Day patrons** can fire on the **Long Range Valley**.

**SCSA PREMIUM Members can also chaperon on to the SCSA Steel Valley.

Non-Member - Single Day Patron - **\$20 for Each Adult (18 or Older) on the property** – limited to West Valley Only – **Range Access Ends at Close of Day**)

There are - **No GUESTS** - Every Adult is either properly entered on a completed & paid **Range Release** or put **OFF the Property**
